Filing Fees

Court Costs: \$100.00

Requirements

An application to conform a legal name is a special proceeding separate from a name change. It is solely to correct misspellings, inconsistencies or errors on one or more official identity documents evidencing a person's current legal name.

You may apply to conform a legal name only if you have been a Fairfield County Resident for the past 60 days.

The Process

The documents listed below must be prepared by the applicant or an attorney, and submitted to the Court for filing, along with the filing fee. Once the documents have been approved for filing by the Court, the Court will review the filing for approval. Copies of the Judgment Entry will be mailed to the applicant.

The Court reserves the right to require additional documentation be submitted to support the application to conform a legal name, require a criminal background check, or hold a formal hearing on the application.

Note: All paperwork must be typed. We will not accept handwritten documents.

☐ Application to Waive Publication Requirement and Seal File (Form 21.6)

All filings must be single-sided. We will not accept double-sided originals.

Please do not staple original paperwork. We cannot accept filings with staples.

You must list the individual's full name on all paperwork (first, middle and last). No initials may be used.

The blicant must provide proof that it would jeopardize the applicant's personal safety to have the name conformity on the blic record. Please refer to R.C. 2717.11 to determine if you meet the requirements.
	addition to the forms required for <i>initial filing</i> above, the documents listed below must also be submitted, along with any juired attachments. The Judge will review all of the documents and make a determination as to whether it qualifies as a

confidential name conformity. If so, the Court will contact the applicant or attorney to set a hearing, if determined necessary.
